Event rates listed above include tables, chairs, basic set up and tear down, linens and skirting, basic sound and lighting, Wi-Fi access, onsite event manager and security. Multiple space usage on same day receives 50% discount off of lowest use fee. Consecutive day use of same space receives 50% discount after first day. Bartenders, beverages, catering, insurance, a/v equipment, stagehand labor, special sound or lighting and items not in Center's inventory are not included and subject to additional charges. Rates subject to change without notice and a deposit may be required. Equipment, services and labor rate sheet is available upon request.

Commercial - Any individual or organization who does not meet the Community Partner or Local Nonprofit requirements.

Community Partner - Any individual or organization with a presence and billing address in the Fox Cities — cities of Appleton, Kaukauna, Menasha and Neenah; villages of Fox Crossing, Combined Locks, Hortonville, Sherwood, Kimberly and Little Chute; towns of Buchanan, Freedom, Grand Chute, Greenville, Neenah, Clayton, Woodville and Vandenbroek; town and village of Harrison or a Nonprofit (501c3) with office or billing address outside of the Fox Cities.

Local Nonprofit - Any organization that has been designated as a 501(c)3 by the IRS and can provide a copy of the IRS determination letter granting nonprofit status, as well as having office and billing address in the Fox Cities. Qualified education institutions in the Fox Cities also qualify for the Local Nonprofit Rate.
